7. Your comments on specific facts observed :

- Whereas one beneficiary shall receive five fruit plants valued Rs.550/- (Rs. 180/- valued 01 budded plants among Mango/ Orange/ Rambutan/ Durian/ Naran/ Pears/ Jack/ Mangusteen, Rs. 135/- valued 02 budded plants among Avacado/ Anoda/ Beli/ Goraka/ Guava/ Jambola/ Jambo/ Lovi/ Sapadilla/ Kamaranka/ Wood Apple/ Uguressa, Rs. 50/- valued 02 budded plants from Gadiguda/ Passion fruit/ Guava/ Jack/ Jambo/ Lime/ Delum/ Orange) and a vegetable seed pouch it was observed that they did not receive the same.
- As additional space is available providing them with more plants is necessary and it would be helpful towards further strengthening their merest in home garden.
- She is a member of the “Sithamu Govi Kantha Samithiya” and request help in the form of subsidy. Providing such an incentive would be beneficial to make the endeavourer more successful.
- They use only the organic fertilizer for their cultivation. If arrangements are made to proude them with other type of fertilizer at subsidized rate they will be able to obtain a good harvest.
- Providing beneficiaries with protective nets to prevent damage from animals/ watering bucket/ water motor/ hose.
- To organize training and awareness programme to further improve their knowledge in agriculture.
- Introduction of modern technology and higher yielding new varieties.
