Bidding for the Supply of 24,000+/-5%MT of Urea (Granular), 18,000+/-5%MT of Triple Super Phosphate & 18,000+/-5%MT of Muriate of Potash Fertilizers - Bid Nos: 2018/MoA/FER/UR/ICB/01, 2018/MoA/FER/TSP/ICB/01 & 2018/MoA/FER/MOP/ICB/01- to the Ceylon Fertilizer Company Ltd., and the Colombo Commercial Fertilizers Ltd.

The Chairman, Special Standing Cabinet Appointed Procurement Committee (SSCAPC) on behalf of the Secretary, Ministry of Agriculture invites sealed bids from eligible fertilizer suppliers, manufacturers, principals or accredited agents for the supply of 24,000+/-5%MT of Urea (Granular), 18,000+/-5%MT of Triple Super Phosphate & 18,000+/-5%MT of Muriate of Potash in accordance with the C&FFO & CFRCY Liner basis under the payment terms of irrevocable Letter of Credit (LC terms) to the Ceylon Fertilizer Company Ltd., and the Colombo Commercial Fertilizers Ltd as per the details given below:

02. The eligible bidder should satisfy the following requirements;

- i. Registered as a business with the appropriate authority in the respective country for a minimum period of two (02) years to the date of the submission of the bid.
- ii. An experience in the International Trading of Chemical Fertilizer or any other commodities to any country within the immediate past one (01) year to the date of the submission of the bid.
- iii. Minimum annual turnover of US\$ 25 million from the International Trading Business in the immediate preceding financial year.
- iv. In the case of foreign bidder, a local representative/ local agent in Sri Lanka should represent on behalf of the principal.

03. The Bid Security Guarantee required to submit by the bidders should be as follows:

Ltd on payment in cash of a non-refundable bidding fee of Rs. 100,000.00 (Rupees One Hundred Thousand only) per set of Bidding document.

05. Bidding document will be issued free of charge to the eligible pre-qualified suppliers registered under Ministry of Agriculture.

However, the pre-qualified suppliers will have to submit a Bid Security Guarantee in accordance with the Clause No. 3 mentioned above after a deduction of US\$ 60,000 already been submitted in favour of Secretary, Ministry of Agriculture. (If the total Bid Value exceed US\$ 60,000.00, the balance value of the Bid Security Guarantee should be submitted together with the Bid)

06. Bidding documents will be issued on any day, **between 9.30 a.m. and 3.30 p.m. from 02.03.2018 to 08.03.2018 including weekends & holidays.**

07. Bidding will be conducted through International Competitive Bidding Procedure (ICB).

10. All bids must be accompanied by a Bid Security Guarantee (Values of the Bid Security Guarantees for each type of Fertilizers are mentioned under clause no.03 above).
