05. Refundable fee of Bid Security Grantee of Rs. 425,000 (Rupees Four Hundred & Twenty-Five Thousand only) should be submitted along with the bids by Bank Guarantee or Cash Deposit, attaching the receipt or submitting Bank Guarantee.
