2. Scope of Work

- Aware farmers about the ICDP Component II, its benefits, and application procedures.
- Prepare necessary arrangements to identify suitable farmers in collaboration with the VS office range.
- Motivate farmers to get membership of Farmer Societies and Dairy Hubs in collaboration with VS office.
- Guide farmers for evening milking and value chain improvement.
- Motivate farmers for primary production to encourage evening milking in collaboration with the VS office.
- Market facilitating.
- Collect baseline information in selected farms.
- Progress assessment for farm practices.
- Encouraging farmers who have not attended to clean milk production and evening milking to do so.
- Identifying farmers' issues and directing those issues to the Ministry.
- Assist in other tasks within the scope of the project as needed.
- Other duties relevant to this project assigned by the Additional Secretary (Livestock Development).

3. Deliverables

- Qualitative and quantitative data of selected farmers and the value chain.
- Organize farmers into a farmer association or a Dairy Hub
- Identify farmers' needs to support with ICDP-II and direct them to the project benefits.
- Encourage and motivate farmers to improve farm facilities for efficient and clean milk production and evening milking.
- Selection of potential FSs and Dairy hubs to have an evening milk collection facility.
- Coordination of farmers/ relevant institution with the veterinary surgeon's offices, Officials of the Provincial Department of Animal Production and Health.
- Coordination of farmers/ relevant institutions with the Ministry.
- Help to improve farm productivity.

4. Duration and Timeline

The total duration of this assignment is 12 months, and the services can be extended, depending on the needs of the Client.
