- 02. The vehicles listed in Table I may be inspected at the premises of the Ministry of Agriculture, Livestock, Lands, and Irrigation, and the vehicles listed in Table II may be inspected at the address, Mahaweli Livestock Enterprises Ltd, Queen Elizabeth Mawatha, Thambuttegama, from 18.09.2025 to 08.10.2025 on working days between 9:00 a.m. and 3:00 p.m.
- 03. A non-refundable fee of Rs. 1,000.00 shall be paid separately for each vehicle for which the bidders intend to submit offers. The payment shall be made in cash to the Finance Division, First Floor, Ministry Agriculture, Livestock, Lands, and Irrigation. Upon submission of the relevant receipt to the Admin and Procurement Division (Located at the same floor) the bid documents may be obtained from 18.09.2025 to 08.10.2025 during office hours (9:00 AM 3:00 PM).

- 04. Properly prepared bid documents, together with a duplicate, shall be placed separately in two sealed envelopes clearly marked as "Original" and "Duplicate". Both envelopes shall then be enclosed in one large sealed envelope and sent by registered post to the following address, Secretary, Ministry of Agriculture, Livestock, Lands, and Irrigation, 80/5, "Govijana Mandiraya", Rajamalwatta Road, Battaramulla to reach before 2:00 p.m. on 09.10.2025. Alternatively, the sealed bids may be deposited in the tender box placed at the Admin and Procurement Division on the first floor of the Ministry. Bids received after the closing time will be rejected.
- 05. The top left hand corner of the envelope containing the completed bid documents must clearly state: "Sale of Vehicle Removed from Use -2025, Vehicle No." and the registration number of the vehicle should be clearly indicated.
- 06. The refundable bid security indicated against each vehicle in the bid document shall be paid separately in cash to the Finance Division (First Floor) of the Ministry of Agriculture, Livestock, Lands, and Irrigation. The original receipt obtained for such payment shall be submitted along with the bid documents.
- 07. Bids will be opened at 2:00 p.m. on 09.10.2025 at the Auditorium, First Floor, Ministry of Agriculture, Livestock, Lands, and Irrigation. Bidders or their duly authorized representatives may be present at this occasion.
- 08. The Secretary of the Ministry of Agriculture, Livestock, Lands, and Irrigation reserves the right to make the final decision regarding the sale of the above-mentioned vehicles removed from use.
